1. Nothing herein contained shall be construed to represent that alterations to land or building in accordance with these plans shall not violate any of the provisions or building or zoning codes of Fairfax County, to which the property is subject. Further, nothing herein contained shall be construed as a waiver or modification of any said restriction.
2. The Building Ordinance of the Fairfax County Building Department requires that you file plans with the Building Inspector for construction requiring a building permit.
3. I understand and agree that no work on this request shall commence until written approval is given by the Prosperity Heights Architectural Control Committee (ACC) or, in the case of appeals, by the Prosperity Heights Homeowners Association Board of Directors. I understand the ACC requires 4 weeks notification prior to work commencing.
4. I understand that any construction or exterior alteration undertaken by me or on my behalf before approval of this application is not allowed, and that if alterations are made, I may be required to return the property to its former condition at my own expense if this application is disapproved wholly or in part, and that I may be required to pay all legal expenses incurred by the HOA.
5. I understand that members of the ACC are permitted to enter upon my property at any reasonable time for the purpose of inspecting the site of the proposed project, the project in progress, and the completed project and that such entry does not constitute a trespass.
6. I understand that any approval is contingent upon construction or alteration being completed in a workman-like manner.
7. I am aware of and understand the Prosperity Heights Architectural standards concerning this proposed project and agree to abide by those standards.
8. Any alteration or modification of this application by anyone other than the ACC will deem this application void.
9. Any changes by the applicant or homeowner to the scope of work must be submitted to the ACC for review.

A written appeals notice must be filed within 15 days of the ACC's decision. If such notice is not filed within the 15-day period, the applicant will be deemed to have forfeited his/her right to appeal. Appeals must be submitted to board@prosperityheights.org, or the Board president, along with the original application.
